The Consumer Price Index fell 1.3% for the twelve months ending January 2026, mainly due to lower average prices in Transport, Miscellaneous Goods and Services, Furnishings, Household Equipment, and Routine Household Maintenance.

The index for Transport Services fell 15.2%, primarily due to a large decline in the average price of airline fares, particularly to Barbados, over the one-year period. The average fare declined from \$ 2,576.20 to \$ 1,701.32.

The index for Miscellaneous Goods and Services fell 4.8%. The largest contributors to the decline were Hairdressing Salons and Personal Grooming Establishments, down 25.5%, and Other Appliances, Articles, and Products for Personal Care, down 2.5%.

The index for Food decreased by 2.1%. The Index for Vegetables, Fruits, and Fish and Seafood were the largest contributors to the decline in the Food index. In the Vegetable category, all three sub-categories recorded a decrease, with the index for Fresh and Chilled Vegetables recording the largest decrease of 16.3%. Within the category for Fruits, the index for Fresh or Chilled fruit decreased by 2.5%.

The index for All Items Less Food and Energy declined by 1.4%. This decline was influenced by the reductions in the Transport Services, Miscellaneous Goods and Services, and Furnishings and Household Equipment and Routine Household Maintenance.

In January 2026, the Consumer Price Index (CPI) declined by 1.9% compared to December 2025. The Food and Non-Alcoholic Beverages Index decreased by 4.9% over the month. All Items Less Food and Energy declined by 0.9% over the same one-month period.

The index for Food fell 5.0% with seven of the nine major supermarket food groups declining over the one month. The decreases were largely attributed to decreases in the indexes for: Meat and Meat Products (-8.4%), Fish and Seafood (-8.0%), Vegetables (-7.2%), and Fruit (-6.9%). In contrast, the index for Bread and Cereals rose 0.5% while the index for Sugar, Jams, Honey, Chocolate, and Confectionery rose 0.1%.

The Non-Alcoholic Beverages Index declined by 4.1%, driven by a 8.5% decrease in the index for Soft Drinks and Concentrates and a 4.3% decline in the index for Mineral Waters.

The index for All Items less Food and Energy declined by 0.9% over the month. The decrease was caused by a decline in the indexes for Transport Services (-8.0%), Communication (-3.0%) and Miscellaneous goods and services (-1.1%).



¹ Outlets refer to the businesses where prices are collected (e.g supermarkets). The same outlets are used for Food and Non-Alcoholic Beverages, Alcoholic Beverages, Tobacco & Narcotics and some Miscellaneous Goods and Services

What is the Consumer Price Index?

The Consumer Price Index (CPI) is a statistical indicator of changes in the general level of prices of consumer goods and services purchased by private households. The CPI measures price movements of a fixed quality and quantity of goods and services. The mix of these consumer goods and services comprising the CPI are referred to as a "shopping basket." In constructing this "shopping basket", the selected goods and services are organised first by commodity type. They are then divided into sections, then sub-groups and then assigned to a major expenditure category. The Antigua and Barbuda CPI has 26 sections, 30 sub-groups and 12 major categories.

What is the Base Period?

The base period (base year) is the time period that is used as a reference point for measuring the price change of goods and services. The base period for the Antigua and Barbuda CPI is January 2019.

The base period index is represented as 100.0. (Usually presented as 2019 = 100). So for instance, if the April 2020 CPI for chicken legs is 167.1, then it means that the price for chicken legs has gone up by 67.1% since 2019. Similarly, if the January 2020 CPI for bread is 93.1, then the price of bread has dropped by 6.9% compared to its price in 2019.

What is Inflation?

Inflation is the process of rising prices, resulting in diminishing purchasing power of a given amount of money. There are three expressions of price changes:

- year-on-year (*the inflation rate*)
- month-to-month
- annual average (or annualised average)

The annual average CPI is the arithmetic mean of the CPIs of the 12 months.

What are Weights?

Weights are "expenditure shares" that is the proportion of total spending on various consumer goods and services, for example, 20% on rent, 25% food, 15% transport, 10% on utilities and so on. The CPI weights are an expression of household's spending on consumer goods and services.

The weights were drawn from a survey of a sample of households in each month of 2006 (the weight base period). Each household in this sample kept a record of their expenditure for one month. Once completed, the expenditures were added to determine expenditure shares per 1000; these are the weights.

The current weights indicate that, households would spend the most on *Accommodation* (218.3 out of 1000) followed by *Food* (214.2) and *Transportation and Communication* (153.5). Households spend the least on *Alcoholic Drink and Tobacco* (1.6).


Table 3 outlines the distribution of price movements for four inflation periods:

- Jan 2026 compared to Jan 2025
- Dec 2025 compared to Dec 2024
- Jan 2026 compared to Dec 2025

In Jan 2026 compared to Jan 2025, 7 of the 12 main expenditure categories recorded price decreases, while 5 recorded price increases. 11 of the 23 sub-group levels also recorded price increases for some of the items that fall in that level. These collective increases and decreases would account for the magnitude and direction of the current inflation rate. 0 of the 12 main expenditure categories recorded no price changes.

*Section Level is 33 Sections however for comparative purposes between 2023 and 2022 data we are utilizing 12 section levels
